## President's Message: Time for Reflection

My two years as President of the HCLA are coming to an end as of the next AGM, so you'll forgive me if I take a few moments to reflect on our organization, its development, and its future.

I've served under three presidents – Salmas, Vavitsas, and Maniatis – and sat on the board with over twenty different people. I'm struck by how each iteration of the board has left an important mark that the next board has built on. John Salmas's focus was on students. The board established the mentorship program under his guidance, and nearly doubled the size of the scholarships we offer. It was also his suggestion that we segregate funds for those scholarships and keep them separate from our current operating budget. We currently have over \$10,000 segregated for precisely that reason, ensuring that, even if we have some slow financial years, the scholarship program won't suffer as a result.

Speaking of finances, the boards under Jim Vavitas's tenure set the HCLA on a very stable financial track. When I first joined the board, our bank account historically hovered south of the \$10,000 mark. Fast forward to today, and our balance tends to hover in the low \$30,000 mark. This tripling of our accounts occurred under Vavitsas, who had an uncanny ability to raise funds through gala events that took a lot of work to organize, but tended to bring in a lot of money when they succeeded. The financial cushion that those boards built has allowed our organization to take steps to grow its presence and membership.

Eleni Maniatis's tenure is marked by that growth. Under her guidance, the Board re-vamped the website and established our presence in social media like Twitter and LinkedIn; we also made the Legalese a more readable and attractive a newsletter. This helped us grow our membership, which in turn allowed us to attract more and more people to our annual events, like the President's Dinner and AGM. By the time her two-year term ended, the size of our association was rebounding from some low membership numbers we had seen in the previous few years. This growth helped us activate the membership to take on such challenges as establishing the legal clinic, which we also did under her watch.

The boards that I have been privileged to lead have achieved recordsetting membership numbers and have expanded our presence in the wider legal community. We have also expanded the sorts of events we try to organize, in particular by starting to offer free CPD sessions to our members. We have become more prominent participants in organizations like the OBA and the Roundtable of Diversity Associations (RODA), which has seen us present on panels at the OBA's annual meeting and put on a joint CPD session with the Canadian Association of Black Lawyers (CABL). Through these activities, our organization is gaining more of a

reputation in the wider legal community, which I hope will help enhance our organization's legitimacy and lead to more members and activities.

In sum, while we haven't always achieved all of the goals we set out to achieve, looking back over the past seven years, I'd like to think that our association is meeting the expectations of its founding members. Next year marks our 25th anniversary, and I hope that we can use that as a way to re-energize our membership, bring back into the fold many of the members and volunteers who have committed so much time to the association, and put on some sort of party that we'll still be talking about seven years into the future.

### 2014's AGM keynote speaker: Anthony Moustacalis

Last year we were honoured to hear from Ioanna Roumeliotis of the CBC about her coverage of political events in Greece. In previous years, we were privileged to hear from individuals such as Dimitris Azemopoulos, Consul General of Greece in Toronto and member of the Athens Bar Association, and the Honourable Justice Sharpe of Ontario's Court of Appeal. At this year's Annual General Meeting (AGM), we are particularly proud to present Anthony Moustacalis, President of the Criminal Lawyers' Association and long-time member of the HCLA, as our keynote speaker.

Anthony was called to the Bar of Ontario in 1984 and until 1988 worked as an Assistant Crown Attorney. Since that time, he has practised criminal defence law, initially as a partner in Hart and Moustacalis, but since 1990 as the principal in Anthony Moustacalis Barrister & Solicitor.

Throughout his career, Anthony has defended clients in over 50 jury trials and in over 100 appeals to Ontario's Court of Appeal. Two cases of note are:

*R. v. McClure,* an appeal to the Supreme Court of Canada on Solicitor and Client Privilege; and

*R v. Yumnu*, where Anthony represented the Criminal Lawyers' Association as an intervenor at the Supreme Court of Canada on the issue of jury vetting.

Anthony is also a tireless volunteer and great contributor to various associations and causes within the legal community. He has been a dear friend of the HCLA, and acted as our association's treasurer in the 1990's. He served as a Director of the Criminal Lawyers' Association and Treasurer for 8 years. Currently he is the President of the Criminal Lawyers' Association and has been since October of 2013.

We are very much looking forward to hearing Anthony's keynote address at the HCLA's Annual General Meeting on the evening of Thursday June 12 at the Ontario Bar Association.

### Greek law students take first prize at Moot Court

Athens Law School students Persephone Vernadou, Panayiotis Theodoropoulos, Panaviotis Kyriakou and Anna Ventouratou came first in the World Round of the global Moot Court Competition on May 18 at the World Trade Organization headquarters in Geneva, Switzerland, beating a team from Harvard University.

"There are students who work systematically, showing great dedication to their studies even when the university is closed," senior law student Anna Ventouratou, 22, told Kathimerini.

As the team's supervisor, lecturer Anastasios Gourgourinis, told Kathimerini, the competition was organized for the 12thyear in a row by the European Law Students' Association (ELSA) and is aimed at creating mock judicial scenarios in which to test students' skills and aptitude. The teams sent in submissions for the complainant and respondent of a fictitious case written by a World Trade Organization professional. This year's debate was about a legal controversy between two WTO member states – a developed and a developing country semis. - over waste following an unsuccessful privatization.

The competition featured teams from 117 universities around the world. #### Sell-off projects to proceed despite obstacles

Despite growing political and legal complications resulting from the recent elections as well as decisions by the Council of State, the privatizations project is set to continue, state sell-off fund TAIPED has said.

This comes in the aftermath of the leftist SYRIZA party's emergence as the strongest party in the European Parliament elections and the decision on the Athens Water Supply & Sewage Company (EYDAP) by the Council of State (CoS), the country's highest administrative court. The transfer of EYDAP's 34 percent stake from the state to TAIPED will now be reversed, as there are no options for another court battle on the matter. The decision concerns the second stake transferred from the state to the fund, completed in April 2012. The first had concerned a 27 percent stake There is no doubt of course that the election result will comconducted in 2011 as soon as TAIPED was set up.

Fund officials note that the verdict will have to be carefully examined by TAIPED's legal service, which is yet to happen. They stress the decision's complexity, given that it ruled against the transfer of the 34 percent stake, but actually referred to a majority stake (51 percent).

The CoS decision will also affect the privatization of Public Power Corporation (PPC). However it will not affect the sell -off projects that are already under way, concerning the Piraeus and Thessaloniki port authorities, which are continuing unhindered. Nor will it have any bearing on the development of the old Athens airport plot at Elliniko as the CoS has rejected the cases brought by local authorities and citizens.

There hasn't been any impact on the privatizations of the former Hellenic Railways Organization (OSE) group, the TAIPED hired an independent consultant to calculate the regional airports or Athens International Airport (AIA) either. TAIPED's management is about to request that Canadian company PSP, a major stakeholder in AIA, provide it with information on the fund's plans about the further utilization of the airport company. TAIPED intends to proceed to an international tender for the sale of AIA shares, with potential buyers having two options: The first regards the sale of shares without an extension on the duration of the concession contract, and the second with a extension, as the existing contract expires in 2026.



plicate the already troubled privatization process, but this could only be temporary, TAIPED officials estimate. They note that the political will for sell-offs to proceed remains intact, as the case of the Thessaloniki Port Authority has shown. In that case the TAIPED board wanted the issue to freeze after its negative reception in Parliament. However the government and the fund's council of experts insisted on proceeding with the tender given that it constituted a prior action for the disbursement of the 8.5-billion-euro bailout tranche.

The council of experts has also asked for a new valuation of the lease for the Markopoulo Racing Course in eastern Attica in the context of horse-racing organization ODIE's privatization. This is the lease that the preferred bidder will pay after the tender for the concession of the license to organize racing betting.

lease rate for the racing course. The consultant estimated it at 6 million euros per year, but that was deemed too much for investors to pay, as the licensee would effectively have to pay all of the revenues to the owner of the course -i.e.the Greek state that would be the recipient of the course's ownership after ODIE's liquidation. Now TAIPED has seen to the hiring of another consultant, who will also take into account the fact that ODIE's privatization will take place without the company ceasing operations.

## Court calls for rehiring of 397 sacked Finance Ministry cleaners

An Athens court has accepted an appeal by hundreds of Finance Ministry cleaners who were put into a so-called mobility scheme of forced transfers and dismissals, the womens' lawyer Yiannis Karouzos said on Friday, referring to a "landmark decision."

According to Karouzos, the Athens Court of First Instance upheld the appeal by the 397 workers, ordering that the women be rehired.

A total of 465 Finance Ministry cleaning staff who were put in the mobility scheme last year as part of a troika-imposed overhaul of the civil service. Of those, 397 appealed against the decision, describing it as illegal and unconstitutional.

Angry workers have staged a running protest outside the Finance Ministry's headquarters on Nikis Street for months.

The court decision comes as the eight-month period of assessment, during which it is decided whether staff are



transferred to another civil service post or dismissed, is set to expire.

Hundreds of employees in other parts of the broader civil service including the education and health sectors have also protested the mobility scheme, most with industrial action such as strikes rather than legal appeals.

#### Greece denies plan for retroactive tax on foreign bond-

Greece's government on Thursday denied it had instituted a retroactive tax on foreign holders of Greek bonds, saying capital gains booked from early 2012 to the end of last year were subject to the tax regime covering that period.

Greek 10-year bond yields rose to near two-month highs on Thursday, with traders citing a document detailing a retroactive tax on non-resident holders of Greek bonds.

Greek officials, however, said that document had only sought to clarify that the previous tax regime of 33 percent on foreign legal entities and 20 percent on individuals had been abolished starting this year.
