He has no personal stake in the outcome of this litigation. He was unshaken in cross examination." (*Tsitsos v. Poka*, 2021 ONSC 3418, at para 85). These four short sentences describe my dad better than I ever could - despite my advocacy skills, I could never shake my dad in cross-examination about anything!

Thank you for taking the time to indulge me, and learn a bit about my dad. I wish all of you an incredible 2025.

## MEET OUR 2023/2024 JUSTICE KARAKATSANIS STUDENT SCHOLARSHIP RECIPIENTS!

Thank you to all those who applied for the Justice Karakatsanis Student Scholarships! The Board of Directors of the HCLA received several competitive and impressive applications this year and following an anonymized review decided to award the scholarships to two deserving applicants: Phil Paschali and Athanasia Thalia Petsis. Phil and Athanasia each received a scholarship in the amount of \$3,500. Congratulations! Here is some background on our winners:

#### Phil Paschali

Prior to law school, Phil earned a Business Management Degree with a specialization in Law and Business from Ted Rogers School of Management at Toronto Metropolitan University. During his undergraduate years, Phil excelled as a member of the school's DECAU Chapter, winning multiple awards in their business law category, and placing third overall in the International Competition. Soon after, Phil was invited to become a judge for future competitions and acted as a memtor, guiding junior members to success.

Phil began his law school journey as part of the Dual JD program with the University of Windsor's Faculty of Law and University of Detroit Mercy School of Law. During this time, he participated in three moot court competitions, two of which he was an oralist and received distinctions, and one as a legal researcher to the Donald G.H. Bowman National Tax Moot Competition where the team placed in the semi-finals. Phil's commitment to legal excellence led him to become a certified meditator in Michigan, mediating landlord-tenant disputes, and contributing to conflict resolution. After this first year at Windsor's Dual JD Program, Phil decided to transfer to Osgoode where he remained dedicated to pro-bono initiatives and joined Parkdale Community Legal Services. In this role, he provided free legal work to tenants in his final year of law school. ## HCLA AND ONTARIO SECURITIES COMMISSION: PROTECTING SENIORS AND VULNERABLE INVESTORS AGAINST FRAUD

Over the past year, the HCLA has been working with the Ontario Securities Commission (OSC) to bring together an important community presentation related to senior and vulnerable investors. The HCLA, along with the Greek Community of Toronto, were pleased to invite the community to Seniors: Protecting Yourself Against Scams and Fraud, which was held on September 26, 2024. The presentation and interactive discussion focused on common scams, the warning signs of investment fraud and elder financial abuse. The presentation was followed by a discussion with Maria-Christina Spingos, of Spingos Law, who provided information on the various legal options available to seniors and their families.

Chris Allum, Senior Advisor, Investor Engagement and Stakeholder Partnerships of the OSC, presented the warning signs of fraud and scams currently impacting many households. She delved into the warning signs of investor fraud and elder financial abuse and provided practical everyday tips people may use to protect themselves. These ranged from simply hanging up the phone if one couldn't verify the caller, even if they promised to be from the Canada Revenue Agency or a financial institution, to keeping full control of financial balances and paperwork and ensuring to check statements regularly for any changes.

The breadth and sophistication of scams and schemes both online and in person is quite alarming. With the onset of artificial intelligence programs, sophisticated and clever scammers are becoming more convincing. One example given during the discussion was how scammers are using telephonic means to record voice and pitch and then using software to contact unwitting grandparents in a plea to transfer large sums of money.

The infamous grandparents' scam has been elevated such that the scammer pretending to be the grandchild is contacting a grandparent, potentially even speaking in their mother tongue including Greek, and making an urgent plea for funds to be transferred. Artificial intelligence is making the plea far more convincing. The unwitting grandparent may succumb to the fraud because they genuinely believe that the voice on the phone is that of their grandchild. One simple tip Ms. Allum gave was to simply hang up the phone and call back the grandchild to confirm if they in fact made the call.

From Boiler Room Scams to Ponzis, Offshore Investment Scams, Pension Scams and Crypto Scams, white collar crime is rampant. The Ontario courts are also grappling with cases involving alleged investor scams, with one recent case being publicized after an unwitting investor lost more than one million dollars in one such mortgage investment scam and later committed homicide. In some cases, members of the bar are being duped by clients and unwittingly facilitating investor scams.

Advising our clients that promises of high returns with little or no risk, or hearing of hot tips to invest under pressure and with unregistered investors are general signs of investment fraud and these warning signs may protect them from a very expensive and life changing decision. The importance of being aware of regulatory rules and laws contemporaneously is crucial but it's also an ethical obligation.

The OSC has multiple resources to facilitate and educate the public and the bar to prevent fraud and advise our clients responsibly.

Checkbeforeyouinvest.ca is a source available to the public regulated by the OSC which provides background checks to confirm if an investment firm or person is registered. Another source is <u>www.getsmarteraboutmoney.ca</u>.

As part of our work with the OSC, we are pleased to announce that the OSC has translated their fraud, investor protection and introduction to investing materials to Greek. These materials contain important information on protecting against investment fraud, including phishing attempts, identity theft, extortion, romance, and offshore investing scams. The OSC has also provided information on investment products; wills and estate planning; and financial abuse and exploitation, including protecting against financial elder abuse. The website provides a number of downloadable resource kits that include an investment fraud checklist, how to check registration and possible disciplinary action related to an individual or business.

This important information is available on the OSC's website in both <u>English</u> and <u>Greek</u> and was included in the OSC's <u>Investor News</u>, a monthly newsletter available for free by <u>subscription</u>. We strongly encourage you to share this important information with your families, friends, colleagues and the Hellenic community.

The HCLA extends a special thank you to Chris Allum, Judy Man, Investor Office, Investor Engagement Specialist and the OSC for their considerable work on this important initiative.



## THANK YOU LETTER FROM FORMER HCLA PRESIDENT CHRISTINE ARRUDA

Dear HCLA Members,

As my term as President of the HCLA has now come to an end, I wish to express my heartfelt gratitude to each of you for your support and commitment. I am incredibly proud of all that we have accomplished together to not only advance our strategic vision and meet our mandate, but to undertake special projects and initiatives and further support our association. Reflecting upon the last two years, I am reminded of all that we have achieved:

#### Advancing Our Strategic Vision

We advanced our vision of making the HCLA a truly national organization through broader provincial representation. The HCLA now has members of its Board of Directors situated in multiple provinces, members located across the country and scholarship recipients residing outside the province of Ontario. We significantly expanded the number of law student representatives to 12, representing nine law schools including two law schools in the province in Quebec.

#### Meeting Our Mandate

*Network* – This year we successfully brought back the Hellenic Professionals' Gala, co-hosted with the Hippocrates Hellenic Canadian Medical Association and Asclepius Dental Society, following a three-year hiatus caused by the COVID-19 pandemic. We continued to host our popular social events including the Under 8 After 8 and the New Year's Cheer and vasilopita cutting, and launched new events including the Spring Cocktail Mixer and our highly successful Hellenic Women's Networking event.

*Educate* - For our lawyer members, we hosted five continuing professional development ("CPD") events, co-hosted two CPD events with our colleagues from the Roundtable of Legal Diversity Associations ("RODA"), and worked with the Canadian-Ukrainian Legal Alliance to present Legal Careers in Canada for lawyers recently displaced by war. For Hellenic youth, we hosted a webinar, Canadian Legal System for Hellenic Youth to provide an overview of the legal system in Canada.

Advocate - We continued our work with RODA on various diversity initiatives and remained active members of the Ontario Bar Association Diversity Council. We reinvigorated our Mentorship Program matching over 20 mentees with mentors and partnered with Canadian Lawyer magazine to prepare the NextGen Lawyers Survey. We were delighted to have our access to justice initiatives included in the 2023 Progress report on Canada's Justice Development Goals in the categories of Justice Goal 1 – Address Everyday Legal Problems and Justice Goal 6 – Build Capability.

#### **Supporting Our Association**

*Membership Fee Auto-Renewal* – We launched the membership fee auto-renewal making it easier for members to pay their annual membership and freeing up resources to allow the HCLA to focus on bringing members quality programming and events.

*Communications* - The association continued our tradition of publishing The Legalese, our newsletter, curating content that focused on our members and articles of interest. Our social media presence remained robust and we enhanced our email bulletins to ensure members receive timely notice of important training opportunities, judicial vacancies, nominations for legal awards, legal events and other community-related news.

Law Students - Over the past two years, we granted four Justice Karakatsanis Scholarships and procured a new scholarship, the Tsiolis Foundation First Year Law Student Scholarship of which two scholarships were granted this past November. We supported our student members by offering interview and resume review workshops and ensured our law student members had meaningful volunteer opportunities.

#### **Our Special Projects and Initiatives**

Student Guide - For prospective Hellenic law students, particularly first-generation law students, we authored TL  $\epsilon(\pi\epsilon\varsigma)$ ; You Want to be a Lawyer? Our Student Guide to Law School to assist in navigating the path to law school.

Ontario Securities Commission - For the senior and vulnerable members of our community, we hosted a seminar with the Ontario Securities Commission ("OSC"), Seniors: Protecting Against Scams and Fraud and in the process saw the OSC's extensive fraud and investor protection materials translated to Greek.

Archives Donation – We donated the HCLA archives to the Hellenic Heritage Foundation Greek Canadian Archives at York University to be included in the Clara Thomas Archives and Special Collections. The donation will ensure that the work of the HCLA will be preserved to be shared with future generations and form part of the history of Greeks in Canada.

*Charitable Status* – We took a number of steps to begin the process of obtaining charitable status to support the longevity of the association and continue to provide law student scholarships.

Hellenic Women Lawyers – We highlighted Hellenic women judges, lawyers and law students, featuring these accomplished women in our fire-side chats, key-note speaking events, and panel discussions. We are proud to report that the HCLA Board had over 60% representation by women during the last term and that the HCLA Women Presidents Dinner continues to be success.

#### Thank You and Gratitude

On behalf of the HCLA, I would like to thank our Board of Directors, Honourary Directors, and volunteers for their hard work and dedication to the association. 

# WHEN MERITORIOUS OPENING STATEMENTS UNDERMINE MEDIATIONS

It's the norm: opening statements focused on the merits of the case end up angering people more than helping them see the case differently. Mediation, a process where a neutral third party helps both sides negotiate a resolution, often becomes the best way to bridge the gap. But in many cases, trading numbers back and forth, tempered through a shuttled diplomat mediator, can become the only hope for progress. Is there a better way?

Neuroscience confirms that "95% of purchase decisions are driven by emotions subconsciously and then justified with logic afterward."

Intuitively, it makes sense, but rationally it might seem less applicable in technically oriented legal negotiations and more aligned with consumer marketing. While the law's intricacies may not be intuitive to the uninitiated layperson, aren't lawyers the technical experts here?

While many negotiators already engage with their (lay) clients emotionally, it's perhaps even more critical to do so with opposing counsel and sophisticated parties, rather than focus solely on technical and rational specifics. Emotional intuition pervasively influences everyone subconsciously—not only the uninitiated—and can be especially impactful on those who tend to discredit intuition in complex situations.

When understood, we begin to recognize when to let legal arguments flow or hold back, choosing instead to address the emotions of an opposing party. When misjudged, it becomes evident in caucus discussions that speaking to the wrong side leads to assumptions of another other side's naivety, ignorance, or outright dishonesty. This undermines merits-based negotiations, reduces the chances of a favourable settlement, and potentially damages a lawyer's reputation.

Good litigators frame facts persuasively, but great litigators present facts with sensitivity. This sensitivity isn't about avoiding conflict—it's about building credibility. "There's a world of a difference between truth and facts. Facts can obscure the truth." While zeal can reveal good reason, it can also conceal precision. And even if the truth supports one side, an *avoidable* step on another's offside foot is likely to inspire small invisible emotional decisions for the worse. Points we all know, but are harder in practice, especially when the burden of proof lays on an opposing party.

The greatest litigators carefully navigate the intertwined threads of each listener's heart and mind. They pace the nuance of their points throughout the mediation, rather than "front loading" it all in openings—a tactic as unrealistic as breezing through DVP rush hour traffic. This patience helps avoid the all-too-common "argument avalanche".

Hazard: Spreading support thin may spread a decision maker's attention thin.

Injury: Overwhelming an already begrudged attendee risks irritation or disengagement.

Urgent Response: Stopping rolling rocks with *tempting top-of-mind* counters—secondary arguments to rebut and fair generalizations to needlessly complicate.

Outcome: Preventing *what's most important* from being fairly heard, leaving the initiator of the avalanche buried in the rubble.\*

\*This rubble can become the focal point for an entire mediation, blocking the road to resolution.

Less is more, often when less invites more. When we focus on the right problem at the right time, it maintains momentum and makes room for more. Sensitivity allows for meaningful contributions, helping us understand each other's beliefs, address them, and move steadily toward settlement—one small step at a time.
